1. Introduction

1.1 This website (“Website”) is operated by **[BlockConGlobal]** (trading as Blockcon.co). 1.2 Please read these Terms & Conditions carefully before using the Website. 3. Ticket Delivery

The ticket acts as a receipt for the transaction and can be used to redeem entry at the event listed on the ticket. 4. Registration/Booking/Purchasing
